The Company may conduct the Contest concurrently and simultaneously on several participating radio stations owned and not owned by the Company, and in various States, and the Company may add or remove participating stations or change call letters of any participating station at any time during the Contest as announced on the affected station. Participating stations are listed above.

1. Description of Contest/Participation.

- A. Dates of Contest: The Contest will begin October 27, 2008 12:01 am and end on or about November 9, 2008 11:59pm.

NO PURCHASE NECESSARY. PURCHASE DOES NOT INCREASE ODDS OF WINNING. Void where prohibited. Odds of winning depend upon the number of participants. open to US residents, that reside in the Station's Total Survey Area (TSA), as defined by Arbitron Inc. Must be 21 years of age at time of entry. Employees of Clear Channel Broadcasting Inc. and Planned Parenthood, affiliates, subsidiaries, parent companies, advertising agencies, and their immediate families are not eligible to participate.

- B. How to Enter: Register by logging onto the Station's website at www.channel933.com and follow the contest links and complete the on-line registration form. Deadline for registration is 11:59 p.m. on November 9, 2008. Valid contest entries must contain all information requested. Incomplete and/or multiple entries will be disqualified.

- C. How to Play: On or about November 10, 2008 the Station will conduct a random selection from all eligible entries received. One Grand Prize winner will be selected. Winner will be contacted from the information provided on the online registration form. If the Station is unable to contact the winner with the information, provided the Station reserves the right to select another winner at its sole discretion.

Winner must present state authorized identification prior to being awarded the prize. This prize is date specific and the winner or winners must be available on the date specified. If a winner cannot be contacted or is disqualified for any reason, the Company reserves the right to determine an alternate winner or not to award that winner's prize, in its sole discretion. If the contest is open to minors, a parent or guardian of any participant who is a minor must sign a release on behalf of the minor to be eligible to receive a prize, however, the Company reserves the right to refuse to award a prize to any minor. Unless otherwise stated above, only one (1) entry per person. Employees of Clear Channel Broadcasting Inc. and Planned Parenthood, affiliates, subsidiaries, parent companies, and their immediate families are not eligible to participate. If the contest includes the use of an internet tool and the internet voting process fails to operate properly or appears to be tampered with or tainted with errors, fraud or unfair practices, the Company reserves the right to use another means to determine the winner(s), i.e. random selection or appointing a panel of judges. All decisions of the judges are final.

6. Publicity; Use of Personal Information. By participating, where allowed by law, all participants and winner(s) grant the Company exclusive permission to use their names, characters, photographs, voices, and likenesses in connection with promotion of this and other contests and waive any claims to royalty, right, or remuneration for such use. By participating in the Contest, where allowed by law, participants agree that the Company may disclose personal information obtained from participants in the Contest to third parties and use such information for marketing and other purposes.

7. Consumer Created Content. 8. Release. By participating in the Contest, each participant and winner waives any and all claims of liability against the Company, its employees and agents, the Contest's sponsors and their respective employees and agents, for any personal injury or loss which may occur from the conduct of, or participation in, the Contest, or from the use of any prize. In order to receive a prize, participants must sign an official waiver form provided by the Company.

9. Taxes. Station shall follow the applicable laws for conducting contests, including notice to the state attorney general or consumer affairs office, posting of a prize bond, furnishing lists of winners, running specific on-air disclaimers, providing specific written information about the Contest, etc. as required by local and state law.
